

EXPRESSION OF INTEREST REQUIREMENTS

CANE ACCEES ROAD CONSTRUCTION, REPAIRS AND/OR MAINTENANCE **2019/2020**

A. BACKGROUND

Given that the majority of cane is supplied to the mills via lorries it is critical that cane access roads be in trafficable condition during the crushing season in order for the mills to receive the amount of cane required daily for crushing. Therefore, there is a need to upgrade and maintain cane access roads for consistent supply of cane to the mills and also to ensure that mill stoppages due to a lack of cane are minimized.

B. SCOPE OF WORK

Fiji's Cane Farm Access Roads are typically short, gravel/earthen roads and located within and around all the cane districts.

The scope of work involves using Graders, Diggers and Bulldozers to:

- (a) run blade and remove all debris and grass from site;
- (b) level road;
- (c) cut side drains along the road and ensure that drains have adequate water run ways; and
- (d) Re-sheet with 65mm down river gravel not river boulders or sand.
