## **LEADERSHIP**:

- Ensure all work and materials suggested to be ordered by Supervisor are of required quality and cost effective to minimize wastage of materials at all times.

# **OPERATION**

Ensure all FSC policies and procedures are followed at all times.

- Effectively control the movement of all rail traffic to ensure steady and smooth supply of rail cane to the mill at all time.
- Maintain 100% accuracy in weighing.
- Effectively manage and direct the movement of locomotive and other rail traffic
- Ensure that all cane picked by loco crew is properly accounted for and safely brought to the mill
- Prepare loco running orders on timely basis and ensure loco schedule is met
- Ensure obstructions to rail movements is efficiently addressed i.e. reloading is as prompt as possible.
- Accurately and timely enter all relevant details from the ticket into the computerised weighing system.
- Accurately operate the weighing system to capture gross and tare weights according to manufacturer's Instructions and workplace procedures.
- Accurately Report results of the operations and testing of the weighbridge in accordance with manufacturer's instructions and workplace procedures
- Effectively liaise with Traffic Assistants, Shift Engineers and loco crew to ensure steady crush.
- Accurately and efficiently print weights onto the weight slips.
- Accurately prepare crushing slips and lorry delivery reports on a timely basis for management use
- Correctly weigh other commodities as directed when required
- Carry out efficient shift changeover including securing equipment and recording arrangements according to workplace procedure.
- Consistently maintain supply of cane to the carrier to ensure smooth and continuous operation.
- Attend training courses, workshops and in- house training to upgrade skills and knowledge.
- Maintain high housekeeping standards and practices in all area of work
- Ensure to take full care of corporation equipments and machines at all times
- Perform other duties assigned by the Head Weighbridge Clerk.
- Ensure to carryout and safely refill motor vehicles, loaders, locomotives, simplexes, forklift, etc in accordance with standard operating procedures and workplace requirements.
- Properly record and report all activities at the Bowser on a timely basis
- Check and ensure that dry fine sand is available at all times to be used in locomotives
- Restrict entry into the bowser to unauthorized personnel
- Ensure proper shift handover according to workplace procedures
- Maintain high housekeeping standard and ensure to keep the bowzer area clean from oil and lube spillages
- Attend training courses, workshops and in- house training to upgrade skills and knowledge.
- Ensure to take full care of corporation equipments and machines at all times
- Be safety conscious and alert at all times.

#### **COMPLIANCE:**

- Primary responsible and accountable for his own safety while at work
- Ensure he do not knowingly put their fellow workers at risk while at work
- Ensure compliance to operation procedures and safe work procedures.
